2. All interested bidders / parties may attend the auction on the date and time mentioned above.
3. Before conducting the auction each bidder will have to deposit an earnest money of Rs. 5,000/- (Rupees five thousand) only in cash, which will be adjusted / refunded immediately after the auction is over. They will also bring their residential proof for proper address.
4. The successful bidder will have to pay 100% bid amount plus GST 18 % in cash on the spot immediately after the auction of the particular store is over, failing which earnest money will be forfeited i.e. will not be refunded.
5. In case any doubt or clarification required by any bidder, decision of the Presiding Officer of Board of Officer will be final.
6. The auction will be held as per departmental rules and regulation. The Board of Officers who will conduct the auction will have the final right to reject or accept the auction of any stores or lot without assigning any reason.
7. Auction will be conducted individually for each store and not as lot.
8. In case the purchaser fails to lift the stores from the site of auction within the stipulated time the purchaser is liable for being charged ground rent at the prevalent rates up to minimum period of 10 days. Thereafter, the amount deposited by him shall be forfeited and the store will again be put up for auction. No Govt. transportation will be provided to the bidders for shifting of stores.
9. The Commandant, 1st Bn BSF reserves the right to accept / rejected any the bid without assigning any reason or to withdraw any order before auction.
10. Remaining condition of auction will be explained on the spot.
